

## CONGRESS MEMBERS HEAD HOME TO THEIR DISTRICTS!

**DID YOU KNOW?** The Maryland, Virginia, Iowa, Arkansas and Texas state legislatures recently passed parity legislation. This is incredibly exciting, but we still need a federal bill in order to provide protections for health plans regulated at the federal level.

**Background:** As most of you know we had nearly 200 people gather in Washington, DC in March, for our second annual lobby day. This event allowed individuals the opportunity to meet with their legislators, share their personal stories and urge them to support the Prosthetic & Customized Orthotic Act.

**Status:** We are working with our lead sponsors --- Senators Snowe and Harkin and Representatives Miller and Andrews --- to get the bill re-introduced
